The MEMORANDUM OF UNDERSTANDING (hereinafter referred to as MOU) is made between The Bundelkhand University Jhansi, a State University, established by Govt. of Uttar Pradesh vide Uttar Pradesh State University Act 1973 and recognized by University Grant Commission based in Jhansi, Uttar Pradesh, India, (hereinafter called First Party) has professional, technical and vocational study programmes along with facilities for research and BitsizeInnovations.com, a product of GDP CHURN (P) LTD, a company registered under the Companies Act, Ministry of Corporate Affairs, Govt. of India will be the Second Party on the OTHER PART (who for the purpose of this MOU) are hereinafter individually referred to as PARTIES.

OBJECTIVES OF THE AGREEMENT

This Memorandum of Understanding (MOU) between Bundelkhand University and Bitsizeinnovation.com is established with the following objectives:

1. Promotion of Innovation: To encourage and promote innovation among students of Bundelkhand University by jointly organizing the award ceremony for "Manish Srivastava (Alumnus) Rolling Trophy of Bitsize Innovation and Cash prize of 21,000/- (sponsored by second party)" by both parties.

An award of annual cash prize of Rs 21,000/- and the Rolling Trophy will be given to the student /group of students of the institute that clinches the Rolling Trophy for innovation. The amount will be given to the concerned student or distributed equally among all members of the concerned group. This amount will be subject to review and potential increase in the future.

- **2. Skill Development:** To enhance the skills and competencies of students, fostering a culture of continuous learning and adaptability.
- **3. Collaboration:** To facilitate collaboration between Bundelkhand University and Bitsizeinnovation.com in creating opportunities for students to engage in real-world projects, internships, and placements.
- **4. Equal Opportunity:** To uphold the principles of equal opportunity and non-discrimination, ensuring that all students have an equitable chance to benefit from the placement program.
- **5. Feedback and Improvement:** To establish mechanisms for feedback and evaluation, allowing for the continuous improvement of the placement program and related activities.





- **6. Dispute Resolution:** To outline procedures for the amicable resolution of any disputes that may arise during the course of this agreement.
- **7. Long-Term Partnership:** To build a long-term partnership between the parties, with the possibility of extending the MOU beyond its initial term.
- **8.** <u>Scholarship Amt Rs 1000:</u> To Provide an amount of Rs 10,000/- every month for the period of 12 months to Topper Research Scholar of Food Tech (Ph.D) of each batch provided he/she is not getting any financial assistance/fellowship otherwise it will be provided to next topper.

These objectives collectively aim to create a mutually beneficial relationship between Bundelkhand University and Bitsizeinnovation.com, fostering innovation, student development, and collaboration for the betterment of both parties and the broader community.

ARTICLE 1: SCOPE, GOALS, AND FORMS OF COOPERATION

1.1 Scope of Cooperation:

The scope of cooperation under this Memorandum of Understanding (MOU) encompasses the following areas:

- All joint activities not completed at the expiration or termination of the MOU may be continued until their completion under the terms of this MOU.

5.3 Amendments and Modifications:

- No amendment or modification of the MOU shall be valid unless the same is made in writing by both parties or their authorized representatives and specifically stating the same for amendment of the MOU. The modifications/changes shall become part of the MOU and shall be effective from the date on which they are made / executed unless otherwise agreed.

5.4 Financial Terms and Conditions:

- Financial terms and conditions will be decided mutually as per the needs and requirements of both parties. This MOU will be considered solely for placement purposes by both parties, with detailed financial arrangements outlined in a separate agreement, if applicable.

ARTICLE 6: ARBITRATION

6.1 Resolution of Issues

- Unaddressed issues shall be resolved through good-faith negotiation, with resolutions incorporated as amendments.

6.2 Dispute Resolution

- Disputes resolved amicably; unresolved disputes referred to selected representatives.

6.3 Final and Binding Decisions

- Decisions reached through dispute resolution are final and binding.
