# MEMORANDUM OF UNDERSTANDING

# BUNDELKHAND UNIVERSITY AND Barkatullah University, Bhopal

#### FOR FACILITATING

## COLLOBORATIVE TRAINING AND RESEARCH

This MoU agreed and entered into on this .......day of....... Two Thousand and twenty two between Bundelkhand University, Jhansi Uttar Pradesh, India (hereinafter called BU which expression shall where the context so admits mean and include its successors administrator and permitted assigns) of the first party.

#### And

BARKATULLAH UNIVERSITY, BHOPAL, which expression shall where the context so admits, mean and include its successors administrators and permitted assigns) of the second party.

#### Preamble

- 1. The Bundelkhand University will facilitate the following:
- a) Whereas: The University shall recognize Barkatullah University, Bhopal and specific Departments as centres for conducting research work for the award of Post Graduate/Doctoral degrees.
- b) Whereas: The faculty of BARKATULLAH UNIVERSITY, BHOPAL on their individual merits and in accordance with the University rules and regulation shall be appointed as supervisors for guiding research.
- c) Whereas: The University shall provide facilities (laboratories, library etc.) for conducting research work by the students without any cost involvement or implication.
- 2. BARKATULLAH UNIVERSITY, BHOPAL, will facilitate the following:
- a) Whereas: The University shall recognize BU, Jhansi and specific Departments/regional centers as centers for conducting research work for the award of Post Graduate/Doctoral degrees.

- b) Whereas: The faculty /Scientists/Officers/of BU, Jhansi on their individual merits and in accordance with the University rules and regulation shall be appointed as supervisors for guiding research.
- c) Whereas: The University shall provide facilities (laboratories, library etc.) for conducting research work by the students without any cost involvement or implication.

#### 3. General

## a) MODALITIES OF COOPERATION

A Committee comprising three faculties each from BARKATULLAH UNIVERSITY, BHOPAL and BU approved by heads of both Institutes will be responsible for setting up and implementing the envisaged academic and research activities. The manner of collaboration in research project is to be on a work sharing research basis, in which each party carries out a specific complimentary component of the larger project, and in turn obtains access to the total research output of that project.

#### b) FUNDING SOURCES:

Research as imposed on exchange of material or in relation to other concerned areas imposed by the Indian govt. (as well as) rights of patents shall be enforceable along with all other statutory requirements.

The activities carried out under this MoU will be financially supported by their respective institutions separately, and as mentioned from funding agencies permitting joint research. Student training and PhD fees will be applicable as agreed between both the parties. No Party will be financially liable for any claim or interested towards other party for any activity under taken under this MoU.

# c) PROGRANMME MANAGEMENT:

The committee shall meet at least once every year and review the progress on all activities carried out under this Memorandum of Understanding.

This MoU can be amended only by a written consent duly signed by the signatories or their successors. The MoU between the said BUNDELKHAND UNIVERSITY, JHANSI and BARKATULLAH UNIVERSITY, BHOPAL will come into force after getting approval from the competent authorities including signatories or their successors. The parties acknowledge and agree to fulfil all requirements and to undertake all activities identified under this MoU.

#### d) LIMITATION OF LIABILITY:

No party to Memorandum of Understanding shall accept any liability or responsibility nor assert any claim or right or interest against the other party for damage or any loss arising from activities under taken under this Memorandum of Understanding. Intellectual property rights as outcome of collaborative research will be shared between the collaborative researchers from BU and BARKATULLAH UNIVERSITY, BHOPAL as mutually agreed upon.

#### e) DURATION OF AGREEMENT:

This MoU will be effective for a period of 5 years from the date of signature, which may be further extended for another 5 (Five) years.

This Memorandum of Understanding reflects the respective Institution's commitments to terms and conditions mentioned in MoU. This Memorandum of Understanding may be amended or terminated at any time by either party provided that notice of termination or amendment is given by the notifying party to the other party before thirty (30) days of the date on which the termination or the amendments is intended to become effective. The commitments, made before the date of termination of MoU, will continue to be operative.

All the conditions mentioned in MoU will be implemented subject to the provisions of UGC regulations, University Act, statues, ordinance and regulation of both the institutions.
