MEMORANDUM OF UNDERSTANDING

This MoU agreed and entered into on this day 1st July 2022 between Bundelkhand University, Jhansi Uttar Pradesh, India (hereinafter called BU which expression shall where the context so admits, mean and include its successors administrator and permitted assigns) of the first part.

&

M L B Medical college, Jhansi (U.P.) – 284128 of the second part.

PREAMBLE

1. Bundelkhand University, Jhansi WILL FACILITATE THE FOLLOWING

- a) Whereas: The University shall recognize MLB Medical College, JHANSI and specific divisions/regional centers as centers for conducting research work for the award of Post Graduate/Doctoral degrees.
- b) Whereas: The teachers/doctors MLB Medical College, JHANSI JHANSI on their individual merits and in accordance with the University rules and regulation shall be appointed as supervisors/co-supervisors for guiding research.
- c) Whereas: The University shall provide facilities (laboratories, library etc.) for conducting research work by the researchers MLB Medical College, JHANSI – JHANSI without any cost involvement or implication.
- d) Whereas: No change of Supervisor or co-supervisors shall ordinarily be allowed. Change of supervisor and/or co-supervisor may be allowed in special cases where research work of the candidate is likely to suffer on account of supervisor and /or co-supervisor leaving the Institution or on account of his/her death or being unapproachable or when he/she is unwilling to continue to supervise the candidate or any other circumstances necessitating such a change.



- e) Whereas: Candidate seeking registration for the award of Ph.D. degree of BU shall apply on the prescribed application form along with a Comprehensive/Synopsis outlining proposed research and a Certificate from MLB Medical College, JHANSI stating that necessary facilities for undertaking proposed research work are available and shall be made available to the candidate..
- f) Whereas: The BU shall charge prescribed annual fee from each candidate registered with BU until the time of submission of Ph.D. thesis. The Annual Fee to the university shall be payable in advance for each commencing year failing which his/her registration may be cancelled.

2. MLB Medical College, JHANSI , WILL FACILITATE THE FOLLOWING

- a) Whereas: Scientists/Doctors of MLB Medical College, JHANSI -JHANSI and BU desire to undertake collaborative interdisciplinary related areas.
- b) Whereas: Faculty members/scientists of MLB Medical College, JHANSI and BU agree to share expertise and facilities on mutually agreed proposed projects including internal research projects.
- c) Whereas: Faculty members/scientists of MLB Medical College, JHANSI and BU agree to jointly submit research project to national and international funding agencies for extra mural funding.
- d) Whereas: Faculty members/scientists of MLB Medical College, JHANSI and BU agree to obtain approval from the institutional ethics committee as required by their respective institution before commencement of the actual work on research projects (if applicable).
- e) Whereas: Post graduate and Ph.D. students registering with the BU will be allowed to carry out their research work in MLB Medical College, JHANSI as per the requirement and approved plan of work.
- f) Whereas: Make available the existing facilities like laboratory, library, workshop etc. at the MLB Medical College, JHANSI ^{on per vado} free of cost to the student for the approved project work.
- g) Whereas: Periodical meeting of the student's supervisors either at the premises of MLB Medical College, JHANSI or BU.

3. GENERAL

a) MODALITIES OF COOPERATION

A Committee comprising three faculties/senior scientists from MLB Medical College, JHANSI and BU as approved by heads of both Institutes will be responsible for setting up

and implementing the envisaged academic and research activities. The manner of collaboration in research project is to be on a work sharing research basis, in which each party carries out a specific complimentary component of the larger project, and in turn obtains access to the total research output of that project.

In keeping view of environment friendly approach, the M L B Medical college will provide the space and technology for the treatment and disposal of the biomedical , chemical waste and other hospital/hazardous waste .

b) FUNDING SOURCES

Research as imposed on exchange of material or in relation to other concerned areas imposed by the Indian govt. (as well as) rights of patents shall be enforceable along with all other statutory requirements.

The activities carried out under this MoU will be financially supported by their respective institutions separately, and as mentioned from funding agencies permitting joint research.

Student training and Ph.D. fees will be applicable as agreed above between both the parties. No Party will be financially liable for any claim or interests towards other party for any activity under taken under this MoU.

c) PROGRAMME MANAGEMENT

The committee shall meet at least once every year and review the progress on all activities carried out under this Memorandum of Understanding.

This MoU can be amended only by a written consent duly signed by the signatories or their successors. The MoU between the said BUNDELKHAND UNIVERSITY, JHANSI and MLB Medical College, JHANSI will come into force after getting approval from the competent authorities including signatories or their successors. The parties acknowledge and agree to fulfil all requirements and to undertake all activities identified under this MoU.

d) LIMITATION OF LIABILITY

No party to Memorandum of Understanding shall accept any liability or responsibility nor assert any claim or right or interest against the other party for damage or any loss arising from activities under taken under this Memorandum of Understanding. Intellectual properties rights as outcome of collaborative research will be shared between the collaborative researchers from BU and MLB Medical College, JHANSI as mutually agreed upon.

e) DURATION OF MOU

This MoU become effective from the date when signed by both the parties and will be valid for five (05) years. This may be extended for a period suited by both the parties and will be valid for the parties. The confidentiality maintaining period will be of three years from the date of expiry of MoU. Any party may cease its cooperation under this MoU by providing six month written notice to other party.

This MoU is a statement of intent of the parties to cooperate and is not legally binding upon the parties under any circumstances whatsoever. This MoU does not create legally enforceable rights, claim, interest, duty, or obligation in favor of either of the party as against the other party.

f) Miscellaneous: This MOU shall be amended or modified by written MOU consent of both parties.
